Non-Support Warrant Sweep Results in 33 Somerset County Arrests

As part of a statewide roundup, the Somerset County Sheriff's Office last week tracked down 33 people who are delinquent in their court-ordered child support payments and owe an estimated total of \$541,159.33, Somerset County Sheriff Frank Provenzano announced.

From Dec. 4 to 6, thirteen teams of Sheriff's Officers fanned out across Somerset County and parts of the state following leads and checking last-known addresses and workplaces.

"The obligation to financially support your child is not optional," Sheriff Provenzano said. "These arrests call attention to the seriousness of failing to pay child support. It's unfortunate that we have to go to such extreme measures to compel parents to make good on what they owe their own children, especially during the holiday season."

In addition to the 33 arrests, one individual was arrested on an outstanding violation-of-probation warrant from Somerset County.

The Sheriff's Office has an ongoing commitment to the children and families of Somerset County. Since January of this year, the Sheriff's Office has arrested more than 443 deadbeat parents. An additional 730 individuals have been arrested on unrelated offenses.
