‘Operation Jingle Bells’ Results in 71 Arrests

SOMERVILLE - Somerset County Sheriff Frank J. Provenzano has announced the completion of an intensive, six-week, pre-holiday investigation into parents who are accused of being delinquent in paying their court-ordered child support.

The warrant sweep conducted this month resulted in **71 arrests** of deadbeat parents owing a combined total of **\$1,178,199.34**.

“Operation Jingle Bells” not only spanned Somerset County but also reached into various other towns in New Jersey.

“Instead of conducting one giant roundup on a particular night, we split the areas up,” Sheriff Provenzano said. “The roundup stretched as far south as Toms River and as far north as Newark. Our officers made their lists, checked them twice and turned out one of the most successful warrants sweeps in recent years. The results were phenomenal.

“This roundup is part of our ongoing commitment to our children and the families who rely on child support to survive,” he added. “The Sheriff’s Office works continuously throughout the year to locate and arrest parents who are not paying their court-ordered child support.”
